## **PRODUCT INFORMATION**

#### Overview

Steri-Write<sup>™</sup> is a new product that decreases germs on shared pens by providing a clean, sanitized reusable pen to each user. Steri-Write<sup>™</sup> utilizes powerful UV-C germicidal LEDs to kill bacteria and viruses commonly found on shared writing instruments and has been scientifically proven 99.9% effective eradicating these harmful pathogens.\* Steri-Write<sup>™</sup> operates with a touchless delivery mechanism and demonstrates sustainability as pens are returned to be re-sanitized after each use. Steri-Write<sup>™</sup> is user friendly and is 100% chemical free which helps protect our environment.

#### **Unpacking Contents and Accessories**

- Carefully remove the Steri-Write<sup>™</sup> device from the box and place on a sturdy countertop or table.
- Remove all plastic packing from the device.
- Keep children away from all packaging material as it may be harmful.
- Review the Instruction Manual carefully.
- Before installation, check box and packaging for the following contents:
  - 1) Steri-Write<sup>™</sup>
  - 2) Power Adapter and Cord
  - 3) Starter Pen Pack
  - 4) Instruction Manual

#### Product Features (See Figure 1)

- The toggle power switch turns Steri-Write on/off.
- The pen return chamber is a simple slot to return a used pen.
- The conveyor system advances pens through the sanitization chamber to ensure a sanitized pen is always available for dispensing.
- The UV-C germicidal LEDs provide sanitization inside the enclosed sanitizing chamber.

## **PRODUCT INFORMATION**

- The internal electronic timing device and circuit board provide technical specifications ensuring each pen receives the appropriate amount of UV irradiance exposure for sanitization before a pen is dispensed.
- The infrared sensor is designed to dispense a sanitized pen to the end user on demand in a touchless method.
- The LED status signaling icon offers visual confirmation that the sanitization process is complete. (See Table 1)
- The illuminated pen dispensation chamber provides a sanitized pen to the end user.
- Each clean pen drops into the receiving cradle.

## **GUIDELINES FOR USE**

#### Assembly and Set Up Instructions

- 1. With Steri-Write<sup>™</sup> securely positioned on a sturdy countertop or table, plug the power adapter cord into the base of the device. This is the preferred way to power the device.
- 2. If optional battery power is desired, place 8 D batteries in the battery compartment noting the proper orientation of each battery as marked inside the compartment. For optimal performance, rechargeable batteries are highly recommended.
- 3. BEFORE placing new pens in Steri-Write<sup>™</sup>, be sure to remove the protective wax tip

cover from each pen (if applicable).

- 4. Place 14 Steri-Write<sup>™</sup> pens on top of the device. (See Figure 2)
- 5. Turn Steri-Write™ on via the On/Off toggle switch on the right side of the device.
- 6. Pens will automatically load and stop after the 4th pen is loaded to initiate the sanitizing cycle. The sanitizing cycle will run for 45 seconds. Once the first sanitizing cycle of 4 pens is complete, the loading process will automatically continue. When Steri-Write<sup>™</sup> is completely loaded the green pen icon will illuminate s

## **GUIDELINES FOR USE**

- Steri-Write<sup>™</sup> is now fully loaded and ready for use. Always keep 4 pens on the top of the device (near the return slot) to ensure the pen conveyor system remains full. Once the device is fully loaded, it will be ready to dispense clean, sanitized pens on demand.
- 8. To initiate pen dispensing, hold hand in front of the "hand waving icon" near the receiving cradle. (See Figure 3)
- 9. After each use, place the used pen on top of the device to be recycled and re-sanitized.



Figure 3. Visualization of how to summon a sanitized pen. There are touchless sensors within the illuminated area. Hand should be placed within this area to activate the sensors, but hand does not need to touch the Steri-Write<sup>™</sup> device. A clean pen will drop into the cradle to be removed.

## CARE AND MAINTENANCE

#### Oleaning Instructions

To clean, use a soft cloth lightly dampened with water to wipe the outside surface of the Steri-Write<sup>™</sup> device. Allow the device to dry thoroughly before use. CAUTION: do NOT pour or spray liquids into the device , and do NOT allow any liquids to enter any openings in the device. Steri-Write<sup>™</sup> is NOT water resistant.

#### Pen Restocking and Replacement Ordering

Steri-Write<sup>™</sup> is designed to function specifically with the pens supplied with the device. Use ONLY Steri-Write<sup>™</sup> pens. Use of non-Steri-Write pens voids any and all warranties associated with the Steri-Write<sup>™</sup> device. Additional Steri-Write<sup>™</sup> pens are available by visiting our website, **www.steri-write.com**.

#### Battery Usage and Replacement; Device Storage

During battery power operation and to conserve battery life, turn off the Steri-Write™ device when not in use and/or when not attended.

Steri-Write<sup>™</sup> requires eight D batteries to operate on battery power. Replace batteries when low power indicator appears. Rechargeable D batteries are the recommended power source and must be recharged in a separate charging device. Battery life is dependent on device utilization. To replace the batteries, remove the battery compartment cover from the back of the machine and install the batteries noting the proper orientation. Be sure to securely replace the battery compartment cover as Steri-Write<sup>™</sup> will not function unless cover is replaced correctly.

Remove batteries if the Steri-Write<sup>™</sup> device is not in use for a long period of time. Store device in a cool, dry place. Extreme moisture may damage the device or affect its lifespan. Dispose of batteries properly, following local laws.

**Note:** Steri-Write<sup>™</sup> recommends using a quality surge suppressor on all electronics equipment. Voltage variations and spikes can damage electronic components in any system. A quality surge suppressor can eliminate the vast majority of failures attributed to surges.

## **TECHNICAL DATA**

#### UV-C Technology

Ultraviolet (UV) disinfection is the future of sanitation as it does not produce by-products, toxins, or other volatile organic compound emissions. UV disinfection technology has existed for many years, however, Steri-Write<sup>™</sup> is the FIRST and ONLY to use UV technology to sanitize writing instruments. The shortest of UV wavelengths is UV-C (200-400 nanometers) and cannot be seen with the naked eye. Germicidal UV-C is one distinct range of UV light between 200-280nm which is effective in microbial control.

Steri-Write™ utilizes energy efficient UV-C LEDs at a wavelength of 265-270nm for the most effective eradication of harmful pathogens. Steri-Write has been scientifi-

cally studied and programed to dose to deactivate the most on writing instruments. When completely safe. You should shine on your eyes or on your safety features that automatically device is opened.
